BIG REFORMS IN INDIAN AEROSPACE

FDI limit enhanced to 74% from 49% in defense production

Defense offsets and large Indian market; third biggest spender in the world in civil aviation MRO hub.

MRO global market of \$120 billion gives huge opportunity in this sector. Reduction in General sales tax will make significant difference for Indian MRO industry by leveraging low labor cost, availability of huge pool of skilled manpower and talent.

Government of India is going to spend more than 300 billion USD in importing civil aircraft in wide body, single aisle, for regional transport & General aviation. Supply chains both for Indian and global requirements.

The Indian government has taken several reformative actions such as reducing corporate tax up to 17 percent.

Nations such as the US, Japan, South Korea rely on China currently. Since China's debacle in managing the deadly virus outbreak, countries are insisting on corporations to either relocate production or set up alternate units outside.

INDIA REPLACING CHINA?

Companies moving manufacturing base from China to India due to Covid-19.

Sectors such as mobiles, electronics, medical devices, textiles and synthetic fabric, are actively pursuing plans of setting up manufacturing in India.

Google to invest \$10 billion in India, Apple announced 20% of its production to shift from China to India, LAVA mobiles to shift its entire manufacturing unit & similarly Hyundai steel, Posco & Von Wellx, FoxCon to move from China to India.
